B95's "LEE BRICE TICKETS" CONTEST OFFICIAL RULES

(the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.** Listen to the Station during the Contest Periods each weekday (each, a "Selection Day"), when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 810-251-6274. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
