## B95'S "SHANTY CREEK GETAWAY WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WFBE ("Station"), 6317 Taylor Drive, Flint, MI 48507, during available business hours Monday through Friday, on the Station website www.wfbe95.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **B95's "Shanty Creek Getaway Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30 days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. Void where prohibited by law. Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. **Contest Period.** Contest entry period #1 will begin at 6:00 am ET **on January 31, 2025** and will run through 11:59 pm ET **on February 2, 2025** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest. Contest entry period #2 will begin at 6:00 am ET **on February 7, 2025** and will run through 11:59 pm ET **on February 9, 2025** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There are one (1) way to enter:

<u>Text</u>: Send a text message with the keyword "Snow" spelled correctly to 810-251-6274 during the Contest Period. All entries must be received by 11:55 PM on February 2, 2025 to be eligible for a chance to win a prize #1. All entries must be received by 11:55 PM on February 9, 2025 to be eligible for a chance to win a prize #2. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting will not increase an entrant's chances of winning. Limit one (1) entry per person per day, regardless of the method of entry chosen by a listener. Each day of the Contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

4. **Winner Selection.** On or about 11:00 am ET on February 3, 2025, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period #1. On or about 11:00 am ET on February 10, 2025, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period #2. Each

winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. The approximate retail value ("ARV") of each prize is: SIX HUNDRED NINETY DOLLARS. (\$690).

## TOTAL ARV OF ALL CONTEST PRIZES IS: One Thousand Three Hundred Eighty Dollars (\$1,380.)

- 7. Entry Conditions and Release. Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims. judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
